We are pleased to have the services of a retired person to come to Coolah to serve the needs of the community in providing Christian support to all ages across denominations. Coolah has not had a resident minister of religion in Coolah for over five years.

When we were unable to support a fulltime pastor, we had put the Manse out for public rental to help with overheads. Regrettably, this was not a successful endeavour and the Manse has been vacant for over two years.

Now that we have the services of this person, we respectfully request that the general rates for 42 Booyamurra Street, Coolah, PLT 1 DP 98 1830, to be waived as a charity, religious property.

In these trying times, and the uncertain outcome for persons affected by job losses, illness and possibly an increase in actual deaths, we feel that the presence in the community of this person offering counselling and Christian hope is a very timely help in Coolah.


The church congregation is very small and now is unable to meet for regular worship due to social distancing. Having a person next door to the church may well provide a lifeline for support in Coolah.

The news each day is becoming more and more serious, all social supports have been forced to close.

By assisting the local Presbyterian congregation to offer and maintain a traditional form of Christian help, we feel that Council would be doing something to help the community in whatever is ahead.

Thank you for your consideration of this rate waiver, reverting to a waiver that was accorded in the past.

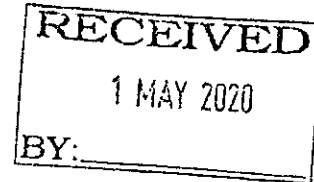
