Ms Parish invited Councillors to observe an area such as Dalby/Chinchilla first hand.

Jane Judd spoke on behalf of environmental groups around the Shire, rather than landowners, with concerns regarding coal seam gas mining. Mrs Judd listed some of the detrimental effects of such mining on the State Conservation Areas, Nature Reserves and the environment in general. Even though the majority of the Pilliga is not in our shire, the local area will be effected. Effects such as fires, explosions, leaks into the atmosphere, as well as water contamination and disturbing of the natural flora and fauna of the area could be common.
