# Burnt fencing wire collection and recycling

Thanks to Upper Hunter Shire Council, two metal recycling companies have offered to load and remove burnt fencing wire, posts and other ferrous metals from farms that have been affected by the Sir Ivan Fire, at no charge to farmers.

They plan to do this in late May, in a "milk run", with another run planned later in the year if required.

Materials will need to be stockpiled in a linear heap (rather than in a big pile), with preferably one stockpile per property.

The stockpile would need to be on farm, off roads and with access suitable for a float to be unloaded and B-doubles or semi-trailers to pick up the material.

Forms will then be provided to the recycling companies and they will contact the affected farmers to arrange pick up.

# The Sir Ivan Recovery Support Service now available

To provide ongoing recovery support to fire affected primary producers, households and communities the NSW Government has provided funding for the Sir Ivan Fire Recovery Support Service. Dedicated Recovery Support Workers hosted by the Department of Primary Industries Rural Resilience Program are now available to help navigate the range of recovery support that exists.

Launched this week by the Minister for Emergency Services The Hon Troy Grant, he said "I encourage everyone who needs it to seek help. You're not being brave by doing it tough. There are people available to offer assistance. Reach out and use them. The Recovery Support Workers will travel out to farms or meet with farmers and their families in town. They will provide a single point of contact to help connect those affected with the assistance they require, whether it is personal, agricultural or financial."

## **Waiving of Council Fees**

At the April Meeting of
Warrumbungle Shire Council,
Council resolved to waive
Development Application,
Construction Certificate, Inspection
and Section 94A fees for those
residents affected by the Sir Ivan
Fire who meet all of the following
criteria:

- (a) have lost their principal place of residence and they meet the LEP requirements that allow construction of a dwelling on that property;
- (b) insurance held does not cover the payment of approval related fees; and
- (c) the property has been confirmed by Council to have been destroyed by the February 2017 Sir Ivan Fire.

Council also resolved to waive tipping fees for receival of friable asbestos, generated by the Sir Ivan Fire, at the Coonabarabran landfill. For more information, please contact Warrumbungle Shire Council on (02) 6849 2000 or (02) 6378 5000.

# Warrumbungle Shire Council Clean Up Assistance

Following the Sir Ivan Fire, **Warrumbungle Shire Council** has received a number of requests from landholders to provide assistance with the clearing of fence lines along fire affected roads. At the March 2017 meeting, Warrumbungle Shire Council resolved that Council provide a subsidy, capped at \$1,000 per property, to pay for plant hire to clear road reserves where trees are deemed a threat to new property infrastructure or road users. Conditions of the subsidy include:

- prior assessment must be conducted by Council
- full road frontage to be treated
- timber to be stacked on property
- fences must be deemed destroyed or damaged beyond repair
- only road reserves on roads maintained by Council are eligible
- only Warrumbungle Shire
   Council ratepayers are eligible
- subsidy is claimable if work undertaken by private contractor

# Warrumbungle Shire Mayor's Bushfire Appeal – community recovery support

Recovery grants of up to \$15,000 per farming enterprise are available to eligible primary producers in the Sir Ivan fire zone who have suffered damage to farm buildings, crops, pasture, stock, fencing and/or tools of trade (equipment/ plant).
