Upper Hunter Shire Council Update

Upper Hunter Shire Council (UHSC) is pleased to provide the following information for people affected by the Sir Ivan Fire.

Tree clearing

UHSC is offering a subsidy of up to \$1,000 to property owners in the Upper Hunter Shire impacted by the Sir Ivan Bushfire, to assist in the clearing of dangerous trees on fence lines. The subsidy, capped at \$1,000 per property owner, can be used to pay for plant hire or materials to assist in clearing Council reserve trees on fence lines where they are a threat to new infrastructure or road users. Council will make an assessment prior to approving the subsidy, which is available until 31 August 2017. Water charges

Cassilis residents can request a waiver for increased water usage charges on their current bill, for increase water usage during the Sir Ivan Fire. Requests for a waiver must be made in writing to UHSC via:

property at the time of the bushfire.

Waste disposal

Cassilis residents and landowners can dispose of fire damage waste free of charge at Upper Hunter Shire Council's (UHSC) Merriwa and Cassilis landfills. The waste must not contain asbestos and would generally come from sheds, fencing and equipment that is fire damaged.

Burnt fencing wire collection and recycling

Thanks to Upper Hunter Shire Council, two metal recycling companies have offered to load and remove burnt fencing wire, posts and other ferrous metals from farms that have been affected by the Sir Ivan Fire, at no charge to farmers.

They plan to do this in late May, in a "milk run", with another run planned later in the year if required.

Materials will need to be stockpiled in a linear heap (rather than in a big pile), with preferably one stockpile per property.

The stockpile would need to be on farm, off roads and with access suitable for a float to be unloaded and B-doubles or semi-trailers to pick up the material.

Forms will then be provided to the recycling companies and they will contact the affected farmers to arrange pick up.

BlazeAid Volunteers Benefit from Dunedoo Showground Upgrade

NSW Department of Primary Industries (DPI) has been pleased to support BlazeAid through upgrades to facilities at the Dunedoo Showgrounds.

The BlazeAid volunteers have been based at the Dunedoo Showgrounds and at Cassilis since the Sir Ivan Fire while they assist landholders recover through rebuilding fencing.

DPI has funded the installation of reverse cycle air conditioning to heat the main facility used as an operations centre and recreation room. As the cold weather bites it is important that the volunteers have proper heating, particularly during their downtime. The air conditioners, and some other upgrades to the facilities, are intended to keep the volunteers as comfortable as possible for as long as possible, so they can focus on their re-fencing efforts.

The air conditioners will remain after the BlazeAid teams wind up, to benefit the Dunedoo community that has done such a tremendous job in supporting BlazeAid.

Recovery Support Workers are now available to travel out to farms or meet with farmers and their families in town. They will provide a single point of contact to help connect those affected with the assistance they require, whether it is personal, agricultural or financial.

'Category C' Recovery Grants for Primary Producers

Recovery grants of up to \$15,000 per farming enterprise are available to eligible primary producers in the Sir Ivan fire zone who have suffered damage to farm buildings, crops, pasture, stock, fencing and/or tools of trade (equipment/ plant).

Talk to an RAA Assessor on 1800 678 593 or your local Rural Financial Counsellor about your eligibility, do not self-assess.

Rural Financial Counselling Service

Questions have been raised regarding the taxability of insurance payouts and if there is provision for the lodging of BAS statements to be deferred. The ATO does provide some information and assistance on these matters as indicated below.

Insurance payouts for purely personal items don't have to be included in your tax return.

However, insurance payouts for items you've used to produce income may have to be included in your tax return. Where you've used items for both personal and income-producing purposes, you need to calculate the percentage of each use. For more information visit

In the days and weeks following a disaster, the ATO understands that your tax responsibilities are not the most important things on your mind. The ATO can give you extra time to meet your obligations. Even if you have lost your tax file number (TFN), the ATO will be able to verify your identity using other information, such as your date of birth, address or bank account details. Are you insured?

Merriwa Sir Ivan Fire Appeal

The application process for the **Merriwa Sir Ivan Fire Appeal** is starting this month.

The process of applying for funds will be outlined on Friday, 2 June 2017, at the Merriwa Landcare Group Inspire Farm Biodiversity Forum being held in Cassilis.

Application Forms will be available on the night, and throughout June from agencies that are supporting the recovery including Local Land Services and local rural produce outlets.

Community engagement will continue throughout June, with the assessment and distribution process commencing in the new financial year.

The Merriwa Sir Ivan Fire Appeal was established by the Merriwa Branch of NSW Farmers who joined forces with Merriwa Show Society to do something to assist landholders and residents affected by the fire. The local and broader farming community quickly jumped on board donating cattle, money, grain transport, products and services.

Cattle have been fed at the Alexander Downs feedlot, who have generously donated significant resources and labour for the Appeal. Donated money has been used to purchase additional livestock through Tony Inder, Rockwell Livestock & Property, enabling the cattle numbers to grow to 550 head, with an aim of fattening 650 head. The goal is to raise \$1 million dollars to assist the recovery, with funds becoming available for release in the new financial year.

Warrumbungle Shire Mayor's Bushfire Appeal

To date the Warrumbungle Shire Mayor's Bushfire Appeal has raised \$195,000 with around \$130,000 worth of funds already distributed to local charities and community groups.

Taking care of your health and wellbeing

After a disaster, there are a number of things which are important to keep in mind to ensure you are able to get through this recovery process.

- Physical health check-ups with your GP are important, even if you don't feel or see an issue.
- Take time for activities of leisure and pleasure which you did before the fire – these will help you to recharge your batteries.
- Spend time with family and friends.
- Try to get back to a routine Continue a healthy lifestyle (eating, sleeping, exercise) even if you don't feel hungry or tired.
- Take time out but don't isolate yourself.
- Write down your worries and concerns.
- Express your feelings in your own time and way.
- Accept help when it is offered.
- Limit the amount of media coverage you are exposed to.
- Don't expect to have all the answers.
- Understand you are not alone in your experience.
- Share knowledge and learnings with one another, so we all learn and recover together.
- Try to avoid withdrawing, overworking, using alcohol or drugs for coping, or making major life decisions without completely looking at all options.

Breaking down depression & building resilience

Delivered by a trained presenter who has a personal experience of a mood disorder or of caring for a loved one, 'Breaking down depression and building resilience' is a 60 minute presentation suitable for general audiences with or without a mood disorder. The presentation will provide accurate information about what mood disorders are, their causes, how to spot early warning signs, what to do and how to build personal resilience. The desired outcome is that people will be better informed, better equipped to identify warning signs and feel more comfortable seeking help and communicating more openly and honestly.
