# Sir Ivan Fire Recovery Committee community newsletter

The Sir Ivan Fire Recovery Committee is producing this newsletter to ensure that all communities affected by the fire, including those from Uarbry, Cassilis, Dunedoo, Coolah and Leadville, have the information needed to recover from this natural disaster.

#### Overview

More than 200 fires burned across the State over the weekend 11-12 February, destroying homes, livestock and crops.

Among these was the Sir Ivan Fire which burned east of Dunedoo and south of Coolah.

# Sir Ivan Fire Recovery Centre

A disaster recovery centre to help residents affected by the Sir Ivan Fire is now open.

# Health and wellbeing

For psychological assistance, there is a mental health team present at the recovery centre. There are also several helplines including:

# **Assistance for primary producers**

#### Loans and transport subsidies

The Rural Assistance Authority (RAA) Natural Disaster Relief Scheme assists primary producers (including commercial fishers and oyster growers), small business operators, non-profit organisations and sporting and recreational clubs affected by declared natural disasters.

Assistance available includes:

- Disaster relief loans of up to \$130,000 are available, subject to certain eligibility criteria, at a concessional interest rate for those in urgent need. These loans may be used for essential working capital, replacement and repair of damage caused to the property and associated improvements not covered by insurance. The repayment term is preceded by a two year interest and repayment free period. Claims must be lodged within six months of the declared date of the disaster.
- Transport subsidies of up to 50 per cent of the cost of transporting fodder and/or water to an affected property and stock to/from agistment are available. These rebates apply to primary producers in areas affected by the fire, subject to eligibility criteria. Maximum subsidy available is \$15,000 per annum. Claims must be submitted no more than six months after first movement. Submit all

claim forms to the RAA with invoices, receipts and other documentation.

## **Safety**

Houses, sheds and other buildings or structures that are burnt in a bushfire can leave potential health and safety hazards in the remaining rubble and ash. These include chemicals, electrical hazards, structural damage and asbestos.

Assessments and sampling are currently being finalised for properties affected by the Sir Ivan Fire.

Please contact Council on 6378 5000 or 02 6849 2000 to confirm if a fire damaged

property has been identified as containing asbestos before accessing the property.

Please wear appropriate personal protective equipment if you do need to access a property and avoid creating or disturbing dust.

If you run a rural business and have not done so please contact SafeWork NSW to see if you may be eligible for small business and quad bike safety improvement rebates (conditions apply).

#### Motor vehicle stamp duty relief

Motorists whose cars have been written off as a result of a natural disaster may be eligible for a stamp duty refund on their replacement vehicle. Refunds are made where the written off vehicle was comprehensively insured and the insurance does not cover duty for a replacement vehicle.

The Office of State Revenue administers these refunds.
