## Extraordinary Meeting - 4 January 2019

#### Councillors

**NOTICE** was given that the Mayor called an **EXTRAORDINARY MEETING** of the Council to be held on 4 January 2019 at the Council Chambers, John Street, Coonabarabran **commencing at 5.00 pm**.

For Councillors' information the Warrumbungle Shire Council's Code of Meeting Practice clause 1.4:

## 1.4 The Mayor may call extraordinary meetings of the Council

I refer Councillors to the Local Government Act 1993 (NSW) section 367:

## 367 Notice of meetings

- 1. The general manager of a council must send to each councillor, at least 3 days before each meeting of the council, a notice specifying the time and place at which and the date on which the meeting is to be held and the business proposed to be transacted at the meeting.
- 2. Notice of less than 3 days may be given of an extraordinary meeting called in an emergency.
- A notice under this section and the agenda for, and the business papers relating to, the meeting may be given to a councillor in electronic form but only if all councillors have facilities to access the notice, agenda and business papers in that form.

And I refer Councillors to the *Local Government (General) Regulation 2005* (NSW) sections 232 and 242:

## 232 Notice of meetings

- 1. This clause prescribes the manner in which the requirements outlined in section 9 (1) of the Act are to be complied with.
- 2. A notice of a meeting of a council or of a committee must be published in a newspaper circulating in the area before the meeting takes place.
- 3. The notice must specify the time and place of the meeting.
- 4. Notice of more than one meeting may be given in the same notice.
- 5. This clause does not apply to an extraordinary meeting of a council or committee.

## Extraordinary Meeting – 4 January 2019

## 242 Agenda for extraordinary meetings

- 1. The general manager must ensure that the agenda for an extraordinary meeting of a council deals only with the matters stated in the notice of the meeting.
- Despite subclause (1), business may be transacted at an extraordinary meeting of a council even though due notice of the business has not been given to councillors. However this can happen only if:
  - (a) a motion is passed to have the business transacted at the meeting, and
  - (b) the business proposed to be brought forward is ruled by the chairperson to be of great urgency.

Such a motion can be moved without notice but only after the business notified in the agenda for the meeting has been disposed of.

3. Despite clause 250, only the mover of a motion referred to in subclause (2) can speak to the motion before it is put.

## Reason for report

## **Summary**

The purpose of this report is to provide Council with an update in relation to Castlereagh Family Day Care and seek direction in relation to actions to be taken regarding the future of Castlereagh Family Day Care.

In accordance with the *Local Government Act 1993* (NSW) ('the Act') and the *Local Government (General) Regulation 2005* (NSW), in the opinion of the General Manager, the following business is of a kind as referred to in section 10A(2) of the Act, and should be dealt with in a part of the meeting closed to the media and public.

The item relates to personnel matters concerning particular individuals (other than councillors) and is classified **CONFIDENTIAL** under section 10A(2)(a) of the Act, which permits the meeting to be closed to the public for business relating to the following:

(a) personnel matters concerning particular individuals (other than councillors)

## **RECOMMENDATION**

That the Castlereagh Family Day Care report be referred to Closed Council pursuant to section 10A(2)(a) of the *Local Government Act 1993* (NSW) on the grounds that the matter deals with personnel matters concerning particular individuals (other than councillors).

## **FURTHER that Council resolve:**

- (a) that Council go into Closed Council to consider business relating to confidential information.
- (b) that pursuant to section 10A(1)-(3) of the *Local Government Act 1993* (NSW), the media and public be excluded from the meeting on the basis that the business to be considered is classified confidential under the provisions of Section 10A(2) as outlined above.
- (c) that the correspondence and reports relevant to the subject business be withheld from access to the media and public as required by section 11(2) of the *Local Government Act* 1993 (NSW).
