d) <u>Installation of 'No Parking' Signs in Laneway behind Caltex Service Station in</u> Dunedoo

Concerns were raised regarding the use of B Double trucks utilising the service lane located between Bolaro Street and Digilah Street in Dunedoo to access the Caltex Service Station. The Committee determined that the matter be referred back to Council to review the conditions of the Development Consent. It was also noted that all streets in Coolah have been approved for B Double access. Council is required to correspond with the complainants regarding the investigation.

e) <u>Highlighting of Blisters in John Street, Coonabarabran</u> **22/2021 RECOMMENDED** that the blisters and adjacent edge lines located in John Street, Coonabarabran at the intersection of Cassilis Street be delineated in accordance with Standards to improve the visibility for motorists at night.
