Provide details of your project and target group and describe how your project will address matters of access, equity and cater to community diversity: The Coolah Preschool Engine Room will be a multi-purpose sensory space adjacent to the Preschool playroom and used as an educational space, therapy space and meeting space.

The Engine Room will enable access to therapy services for children in and around Coolah who currently face significant barriers to access due to the cost involved in travelling to access services in major centres. The Engine Room will promote equity by enabling these children to access services locally (or via telehealth), particularly where families are suffering economic disadvantage.

The Engine Room will also enable to access for Preschool educators to learning and development opportunities which are currently limited due to the cost of travel and COVID-19 concerns and restrictions.

Details of how Council's funds will be expended: The Council's funds will be used to purchase sensory equipment to be used in the Engine Room. Other sources of funds will be used to complete other parts of the Engine Room project.

Please list any donations given to your organisation by Council, over the last two years: Nil.

What other financial support does your organisation receive? : Coolah Preschool is funded by a combination of NSW Government Department of Education funding based on enrolments, fees from families and other grants that may arise.

How will the donation you have requested benefit Warrumbungle Shire residents and meet the outcomes of Council's Community Strategic Plan and/or Delivery Program and address gaps in service provision? : The donation will meet the outcomes of Council's Community Strategic Plan by ensuring the ongoing provision of a high quality education and care service at Coolah Preschool, which fits within Council's goals for "Public Infrastructure and Services" and "Community and Culture".

The Engine Room will be fitted out with sensory equipment and IT equipment to enable hands-on and remote education and therapy for children within Coolah and its surrounds, in particular children with arousal-regulation issues and other additional needs. There are minimal therapy services available in Coolah to support children with additional needs and no therapy spaces available in town. The Engine Room will address this gap in service provision.

The Engine Room will also enable online training and meetings for Preschool educators, and access to telehealth for speech and occupational therapy for children. There are no spaces/services currently available in Coolah to enable access to such services and the Engine Room will also address this gap in service provision.

Project Description - Centacare Bathurst are partnering with Joblink Plus to host the Coonabarabran Careers Expo 2021. It will be held on Friday 10 September from 10am – 2pm at the Town Hall, Coonabarabran.
The aim of the event is to provide access and information to inform and guide career options, employment and further training opportunities. The event will be free and will showcase diverse local, state and national employers such as the Shire Council, Coinda Nursing Home, NSW Health, NSW Police, Defence Force & Woolworths to name a few. We are also inviting organisations that deal with apprenticeships, career pathway advisors, tertiary education providers, training providers, and universities.
In addition, a special guest speaker and presentations will be conducted during the event as per the event schedule.
A COVID-safe plan will be developed to ensure compliance with current NSW Health regulations and a risk management plan will also be undertaken to support the event.
Target Group - We respect, value and recognise the diversity in our community and the event will be open to all people, we will specifically still target youth from 15-24 whilst still recognising that an older cohort may be interested in a career change or information on further education and training.
Details of how Council's funds will be expended: The funds will be used for catering for the event, which includes coffee, cakes and sandwiches. It will be held over morning tea and lunch so it's important that there is catering to support the free event, making it accessible for all.

Provide details of your project and target group and describe how your project will address matters of access, equity and cater to community diversity: Coolah Central Schools, Youth community are developing and aiming to run a community focused event by young people for the Coolah School and wider community to promote a town culture of 'together more than ever', which will develop positive mental health and social interaction whilst also celebrating the success of young people in the community through the focus on National Youth Week.

The activities will promote student planning and management skills in developing and running food stalls, carnival activities and positive interaction, whilst also including the hire of healthy active amusement activities. After a year of closure and Covid restricting community engagement and community involvement with the School has been limited, this event gives the students the ability to develop positive social interaction skills and support a Coolah Community family and youth friendly event which has not happen at the school and broader community in well over 18 months.

The youth of Coolah have been restricted in social gathering and the ability to develop and grow work ready skills. This program and event developed by the student and school community aims to address the suppression and lack of family friendly events which has not happened due to Covid in our local area.

Details of how Council's funds will be expended: We aim to use the funding provided by council for the promotion of community and cultural development in the ability to make this an inclusive event for our lower socioeconomic students and families in a remote community that often miss out on the opportunities and ability to interact positively within the community.

The support in funding also gives the students the ability to deliver a range of activities and choices over the event scheduled on 28/4/2021 which will be a 6 hour event focusing on attracting not only Coolah Community but the whole shire to celebrate and work on the theme of Together more than ever in 2021.

The finances provided will support the development and implementation of the activities on the day. This will be supported by promotion through out the shire by student developed marketing program, including, direct letter box drop, social media and radio

The Council has provided \$500 funding to host a very successful chef in the development of trade skills and employability.

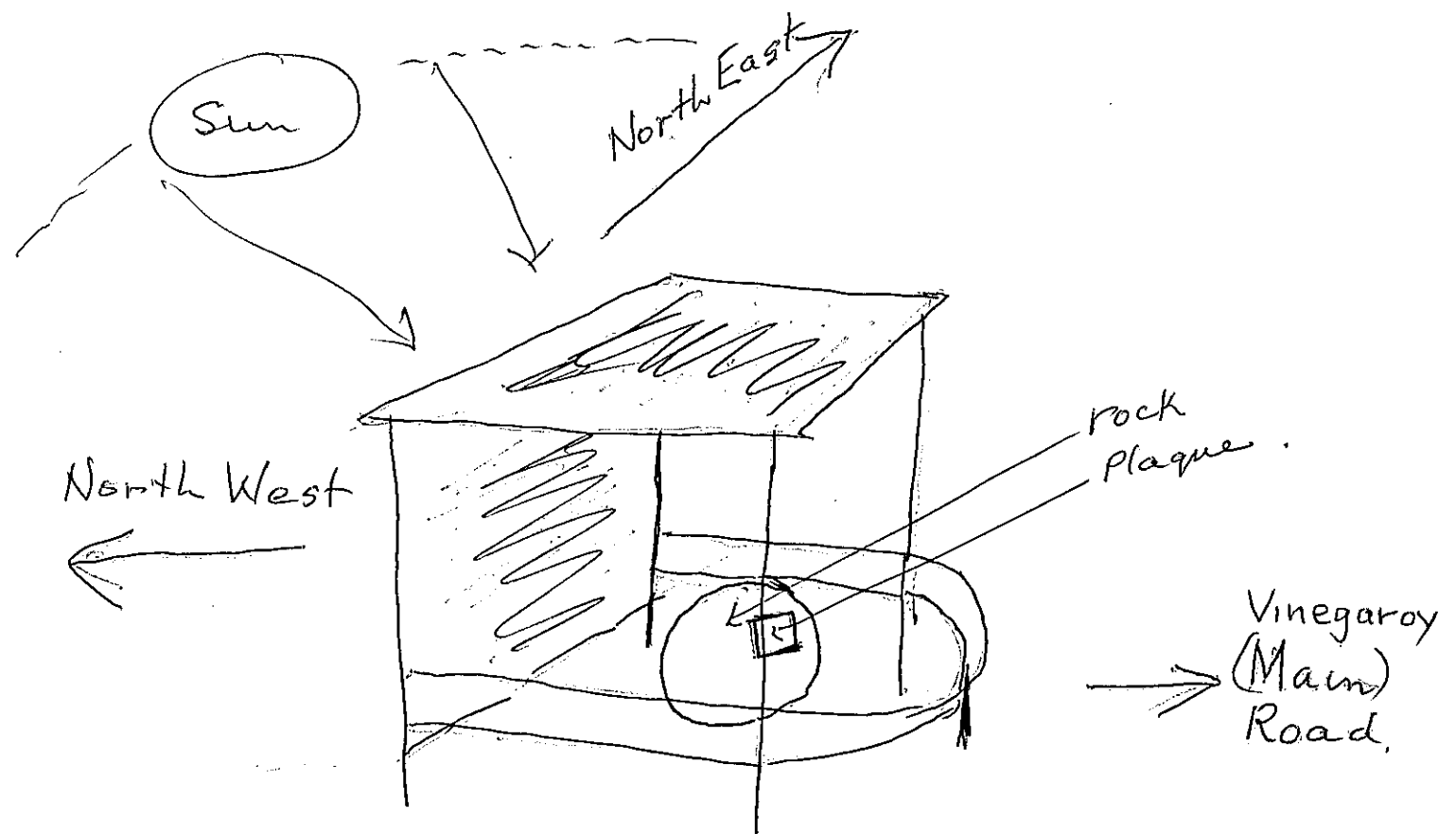


