All activities contribute strongly to the social needs and aspirations and benefits to the community.

It is now intended to expand awareness of RDA Coonabarabran's services and vision to other nearby or geographical locations in the Shire to ensure any persons with disabilities and their carers are aware of our programmes and can be introduced to the positive benefits provided to all.

Members of RDA Coonabarabran strongly feel the services and outlets being provided by the group to people with disabilities supports the efforts and goals outlined in Council's Disability Inclusion Action Plan 2017-2021 in making the Warrumbungle Shire more inclusive of people with disability.

As you would be aware, the Leadville community is experiencing a resurgence in recent years, and being a bounce-back from the difficulties and hardship experienced as a result of the Sir Ivan fires in February 2017. Our community is immensely proud of all we have achieved, and particularly in recent years with the NSW Government Community Grant to refurbish existing infrastructure in and around our local hall.

# **INTRODUCTION**
