

### Submission to WSC 2021/2022 Budget – Bike/Walking Trail Plan Extension – DUNEDOO

Dear Roger

In 2016, WSC carried out shire wide bike/walking track development plans to increase physical activity and better town access to sporting venues including the swimming pool, for better physical, mental and social health

I am asking if WSC can make allowances in the forthcoming budget, to upgrade Dunedoo town plan to take in the perimeter of the town please? This will include the river, the Woodland Learning Centre and an adjoining area of woodland to the east where the main Aboriginal scar trees are.

An upgraded plan will enhance the chances of making a start to this long overdue project.

Progressive towns with a rive, always have a river walk and, water makes an interesting ambiance to nature. Our river, has beautiful scenery across the river flats and rolling hills to the north, past the football ground and to our much anticipated retirement village, where the present walking track plan is in place.

The Dunedoo Woodland Learning Centre, is a fenced area bordering three sides of the Dunedoo cemetery and considered an endangered White Box Ecosystem remnant. The WLC committee, twenty plus years ago, gained this area from the then Pastures Protection Board, (Now LLS). This was done for educational and social purposes, seed collection and system preservation. There are now less than 0.3% of these remnants remaining in the state and is particularly valuable, including, to our community. Fencing, a shelter, signage, seating, sculptors, bird brochures and developed educational materials are in place. Soil erosion mitigation has taken place. Upgrades are ongoing. With one scar tree in the actual fenced area, in the surrounding arear, including within the town boundary, there are excellent examples of Aboriginal scar trees, and one with toe holds for climbing.

I ask if this bike/walking track plan can be upgraded/extended, to enable the community to apply for grants to enhance these projects and our town.

I thank you in anticipation.

I invite all councillors and interested staff to see these areas before the budget allocation deadl	line.
I'm happy to show you around. I just need about thirty seconds to change my shoes.

Submission to WSC 2021/2022 Budget – Water access availability for RV Travellers - DUNEDOO

#### Dear Roger

I write to ask if water availability and a card payment option for RV travellers can be included in the forthcoming budget please? It was stated in the Community Consultation Meeting Action List 21.4.2021 that investigations suggest this service and payment system could be carried out at a cost of \$30,000.

Being an RV traveller, I now realise how important it is to access clean water when traversing isolated areas such as ours. An internet sight such as WI Camps displays areas where water, dump points, caravan parks, camping areas etc are available and \$. All RVs look at these sights before deciding their route.

If these necessities are available here, Dunedoo will be known as the place to stop. Food and fuel will also be purchased. Dunedoo is the gateway to the Warrumbungle's, and all places north, south, east and west. Also, an extra person in town overnight, for one year, creates another job.

Due to increased tourism, with the help of the Silo Art and no overseas travel, out little town has recently seen three new businesses started in the street with two new/upgraded service stations and a craft brewery pending. The beer man is setting up a Brewers Trail. Dunedoo is/will be included on Silo Art Trail. The Central West Cycle Club is increasing daily with all needing accommodation and food. (Probably not much water for the cyclists, but good word of mouth is gold to us).

I ask again that \$30,000 be included in the budget for the survival of RV travellers and RV tourism in the Central West. May I suggest **it be placed within easy access where the dump point is located.** This placement will also enable travellers who are/are not stopping overnight easy access to showers at the Caravan Park and the new servo for fuel which employs locals. Another service, another reason to come to Dunedoo.

Dear Mr Parker,

I went in to the Coolah office this afternoon and they advised I write to you.

Last week I received an Urgent Reminder for Rates for Uarbry Hall, which had been sent to the wrong address originally. Checking our files, we have not received a Rates Notice since 2017, and this was for a zero amount.

Due to the late arrival of the latest Notice, we did not request a Council Donation/Waiver prior to the April Council meeting that decided the annual Donations list. Since the Hall became active again in the late 1990's Council has always waived, or via some method, removed the need for the Hall to pay rates.

The outstanding Rates of \$787.09 is a large amount for us, considering the minimal services required from Council.

Also, in 2017 we were 'Village 2 non rateable' but have now become 'Village 2 business'? We are certainly not a business and ask that we be returned to the previous status please.

Is there a way we can remove or reduce the rates amount as this will be a severe impost on the current and future Hall financial status.

Written I am writing this letter to OBJECT the proposed rate increase in the draft operational plan for 2021-

Great financial hardship will arise from tis forcing ratepayers to sell up and leave Coonabarabran Shire.

As you have stated in your plan, the average weekly income of Coonabarabran Shire residents is \$479.00. And this is for those who been able to gain employment during their working years. Pensioners make much less than this as do those on government benefits due to the lack of opportunity for employment in the shire.

As a ratepayer myself and single mother of one school age child. I average this income even as an educated member of society as a registered nurse at Coonabarabran Hospital. I am unable to work full time due to lack of childcare services for school age children and cannot rely on family for support as they two need to work to support themselves and their families.

With this average wage of \$479.00 we must also pay for our basic human rights as per the UNIVERSAL DECERLATION OF HUMAN RIGHTS of shelter, food, clean water and continuous increase in living conditions. By increase the rate increase you are thereby lowering the ability for residents to provide the basic human rights for themselves and their families.

The weekly expenses:

- -Housing (mortgage vs rent) \$250 per week in COONABARABRAN SHIRE
- -Food \$ 141 per week (based on a Canstar Blue survey of more than 2,600 households (of all sizes).
- -Electricity \$27.3 per week (based on a Canstar Blue survey of more than 2,600 households (of all sizes).
- -Water \$ 20.9 (based on a Canstar Blue survey of more than 2,600 households (of all sizes).

Just these basic human rights total a cost of \$439.2 per week.

This leaves residents with an average of \$39.80 per week to provide all the other necessities such as:

- -Child care -to actually be able to work;
- -Transport -as we live in a rural and remote town with poor facilities.
- -Healthcare- Coonabarabran has poor access to healthcare services and are required to travel to larger regional towns to access healthcare. These services are also continuously rising in cost.
- -Education- Coonabarabran Shire has poor access to education to better our standards of living. The Coonabarabran TAFE offers very few courses in which there is lack of employment opportunities post study in Coonabarabran Shire along with the ever increasing tuition costs in which government subsidies are increasingly harder to gain to afford to study.

I object the rate increase of 22% onto ratepayers based on the fact of poor asset management of Coonabarabran Shire and misguided plans for the future development of Coonabarabran Shire. Ratepayers have previously been slapped with rate increases only a few years ago and we have nothing to show for it. Coonabarabran Shire is continuing to dissolve into a ghost town with minimal reason for visitors to stop and spend money.

The added 22% increase on ratepayers is going to cause great financial hardship to residents of Coonabarabran shire and force residents to sell up and leave town as rates are cheaper in other shires.

### Re: Submission Draft Operational Plan for 2021/22

Please find below submission on the draft Operational Plan 2021/22 relating to non-domestic recycling bins and charges.

There is the opportunity to offer commercial businesses larger recycling bins with capacity of 360 litres. At present, Council's fees and charges apply to recycling bins with capacity of 240 litres only.

To provide the option of 360 litre recycling bins it is recommended the following changes are made to the draft Revenue Policy and Fees and Charges 2021/2022;

- within the table on page 12 the line item that states Non-Domestic Recycling Additional Bin Charge requires the words 240 litre to be included to demonstrate the additional charge of \$110 relates to 240 litre recycling bin.
- within the same table on page 12, a new line should be included at the bottom
  of the table providing 360 litre recycling bins as an option for Non-Domestic
  Recycling for the price of \$140
- further, on page 18 the cost to purchase a 360 litre sulo bin needs to be included at a cost of \$141, and cost of replacement lid \$40.

It is also noted the reference to s94A Contribution fees is incorrect as per page 20, and requires amending to align with Council's adopted Developer Contributions Plan; the contribution for development with proposed cost more than \$200,000 is 1% of proposed cost of the development, not 0.1%.
