BUSINESS ARISING FROM THE MINUTES

The following matters were noted as outstanding:

- Black Stump Way Council request to NHVR that any road in the Warrumbungle Shire that is a 25 metre B Double Route be converted to a 26 metre B Double Route. Matter to be followed up with Council's Director Technical Services.
- O 'No Parking' Signs in the Coonabarabran CBD audit of 'No Parking' signs to be undertaken and a plan prepared. Council to liaise with the Coonabarabran Chamber of Commerce regarding timed parking. Revised plan to be prepared and database to be amended to include full description of signs followed by the identification of inconsistent signage.
- Delineators on kerb blister in John Street at pedestrian crossing.
- o Installation of Wide Load Detour sign on Baradine Road
- Removal of loose gravel at the intersection of Dandry Road and Newell Highway
- Installation of end of road chevron at intersection of Dandry Road and Newell Highway – referral to TfNSW.
- o Installation of advance notice signs for Coolah Sport & Recreation Ground.
- Installation of timed bus zone on northern side of Bullinda Street at Trainlink bus stop.

f) Traffic Control Plan for ANZAC Day march in Mendooran
The Committee noted that the TCPs presented show different start and stop locations of the Mendooran ANZAC Day. It was agreed that contact be made with Mendooran RSL and to advise TfNSW if previously approved TCP requires modification.

The following matters were discussed without resolution;

- No action to be taken to be taken by the Traffic Committee in regard to a request by a property owner adjacent to David Knight Drive to fence the road reserve.
- There are no issues with a proposal by Coonabarabran Local Aboriginal Land Council for the Sorry Day March to pause at the intersection of Cassilis Street and John Street to conduct a flag raising ceremony at poles in front of the Council Administration Building.
- A suggestion by TfNSW that the speed limit in John Street, within the Coonabarabran CBD, could be changed to 40kph was noted. There was concern expressed however that during school times the speed limit along the entire length of John Street would effectively be reduced to 40kph. TfNSW also suggested that the speed limit in Bolaro Street Dunedoo, within the CBD, could be reduced to 40kph.
