I write in opposition of the road naming proposal put forward by Warrumbungle Shire Council relating to changes in the naming of Orana Road, Coolah to Girragulang Road.

My family property known as is located on what has been known by locals as Orana Road for as long as 80 years. Orana Road runs from The Black Stump Way in its entirety to meet with Moorefield Road. Current signage confirms this.

It is noted that on Google Maps, this road is shown as Girragulang Road. When this change occurred, no one is quite sure as there had been absolutely no community consultation. It is disappointing to see that Council are consulting the residents and community now after it seems this decision has already been made on their behalf, and only after it has come to light following an incident where emergency services were required to attend an address that was conveyed as Orana Road by a resident, to be told by the operator that it does not exist on a mapping system.

It is pertinent that there is harmony between signage and mapping systems to ensure future emergency response times are not prolonged due to confusion in road names.

With the above in mind, I do hope Council listen to the overwhelming resident & community opposition of having the road name changed from Orana Road to Gurragulang Road.
