### **BUSINESS ARISING FROM THE MINUTES**

The following matters were noted as outstanding:

- Black Stump Way – Council request to NHVR that any road in the Warrumbungle Shire that is a 25 metre B Double Route be converted to a 26 metre B Double Route. *Matter to be followed up with Council's Director Technical Services.*
- Audit of 'No Parking' Signs in Coonabarabran CBD – 'No Parking' signs to be replaced and installed as per audit.
- 40kph Speed Zones for Coonabarabran and Dunedoo – *submissions closed on 21 December 2021. Considered at February Council meeting and resolved to reject proposal.*
- Extension of double unbroken lines on the Newell Highway from Gardener Street to Dandry Road, Coonabarabran. *Works scheduled with TfNSW Area Maintenance Manager.*
- Installation of Disabled Car Parking Space in Bolaro Street, Dunedoo - further investigations required in relation to a suitable design and location.
- ARTC level crossing on Golden Highway at Dunedoo – installation of yellow box markings and signage – *Council to schedule works under the RMCC.*
- Overhanging trees on the southern travel lane of Oxley Highway from the intersection of Yaminbah Road for approximately 15km – *Assessment undertaken by TfNSW and works to be scheduled with Arborist.*
- Installation of additional public toilet service sign at the rear of Little Timor Street Plaza, Coonabarabran – *works scheduled for week commencing 9 May 2022.*
- 'No Stopping' and '45° Angle Parking' signs to be reinstalled in John Street, Coonabarabran in front of the Shell Service Station.
- Marking of zig zag lines at pedestrian crossings located in John Street, Coonabarabran near the Council Office and swimming pool – *Council to provide TfNSW with a quotation.*
- Replacement of rail line at Mary Jane Cain Bridge, Coonabarabran – *TfNSW to undertake works.*
- Implementation of 80kph Speed Zones at Rail Crossings – *TfNSW awaiting quotation from Council for the supply and installation.*
- Relocation of parking signs in John Street, Coonabarabran at entrance of Little Timor Street Plaza – *works to be undertaken on 5 May 2022.*

Request to Delineate Driveway Access at 30 Dalgarno Street, Coonabarabran

The Committee was advised that line marking to delineate the driveway access at 30 Dalgarno Street, Coonabarabran had been completed. The NSW Police suggested that the parking sign at this site may need to be relocated to the other side of the driveway access. Council to inspect and undertake works if required.

Reinstallation of Sign at Intersection of Castlereagh Highway and Barney's Reef Road, Birriwa

TfNSW advised the Committee that the new sign to be located at the intersection of Castlereagh Highway and Barney's Reef Road, Birriwa in relation to the murder of Senior Constable John Ward by the Chinese Bushranger Sam Poo has been ordered and that Council is awaiting delivery prior to installation.
