AGENDA ITEMS

- a) Updated draft Gates and Grids on Public Roads Policy
 - Grading the 20m either side of the ramp was discussed at length with regards to who should be responsible for this task. DTS read the Road Regulation out to the Group and it was agreed that the Clause would stay as it was written with the option for land owners to seek Council complete the works under a Private Works Agreement.
 - "notice period" on page 3 to be clarified in the context of minor/major works
 - On page 5 change aluminium to galvanised and check all items in the specifications against legislation to ensure they are up to date.

b) Road widths

DTS read out the widths. WSC currently designed to Local Road: 6.0m sealed width (3m per lane), 1.0m shoulder (one side), 8.0m total formation width. Regional Road: 7.0m sealed width (3.5m per lane), 1.25m shoulder (one side), 9.5m total formation width.

c) Natural Disaster Response and Recovery Update

DTS provided an update on the progress of works as written in the Natural Disaster Response and Recovery Report in the February Business Paper. A discussion around resourcing and Council's ability to deliver the works was held. The issue of deferring current programmed maintenance works to future years was raised in the context of creating a backlog of works to be dealt with once the natural disaster works were complete. It was noted that other Councils are in the same situation and that attracting resources is one of the biggest challenges to delivering works in the timeframes allocated by the government.

d) Unsealed Roads Maintenance training

DTS outlined the training to be rolled out to roads maintenance crews. Several staff operating graders, rollers and water carts are to take place in the training aimed at arming them with skills and knowledge specific to maintaining WSC unsealed roads. Council will receive improvement action plans, standard procedure templates and procedures. A report benchmarking operational and management techniques with the National Database and Industry Best Practice will also be received along with the trainers WSC specific recommended actions and their cost benefits.

GENERAL BUSINESS

- Overhanging branches on roads in the carriage way were discussed.
- It was stated that the amount of gravel that had been pushed up was not enough for the flood damage works that had been planned.
