Council has received the tender schedules from the consultant. Costs for this phase can by fully recovered from NSW Health. 22.06.21 – Council is waiting for written confirmation from Health on the cost reimbursement, which is depending on the cost estimate of the consultant for the overall project; this needs to be known to Health prior to commitment to guarantee sufficient cashflow.
