

Level 4 Water Restriction

The following restrictions on the use of town water in Mendooran are now in place. These restrictions will be in place until further notice. This notice is given in accordance with clause 137 of the *Local Government (General) Regulation 2005* (NSW). Your cooperation in complying with these restrictions is appreciated. Failure to comply may result in restrictions or disconnection of services.

Domestic – target water consumption of 200 litres per person, per day	
Watering of lawns	Not permitted
Watering of residential gardens	Watering systems, non fixed sprinklers, hand held hoses not permitted at any time. Only microsprays, drip systems, soaker hoses, between 6.00pm till 8.00pm on Wednesday and Sunday.
First fill and/or filling or topping up of: <ul style="list-style-type: none"> Garden water features 	Permitted
Topping up of: <ul style="list-style-type: none"> Swimming pools or spas 	Only between hours of 7.00am till 9.00am and between 6.00pm till 8.00pm, every day. Pool covers must be used.
First Fill of: <ul style="list-style-type: none"> Swimming pools or spas 	Only with Council permission and after water saving elsewhere within the property. Covers must be used.
Inflatable of temporary children's pools	Permitted
Irrigation of new turf	Not permitted
Washing down walls or paved surfaces	Not permitted
Washing cars at home	Permitted with bucket only on lawn between 9:00am until 12pm/Noon any day.
Baths and showers	Five (5) minute showers, one bath per person per day.
Washing of clothes	Full loads only permitted
Evaporative air conditioners	Permitted only between 7.00am till 12am/Midnight daily

Commercial and Non-Residential	
Watering of lawns	Not permitted
Watering of gardens	Watering systems, non fixed sprinklers, hand held hoses not permitted at any time. Only microsprays, drip systems, soaker hoses, between 6.00pm till 8.00pm on Wednesday and Sunday.
First fill of public swimming pools or spas, including motels	Only with Council permission and after water saving elsewhere within the property. Covers must be used.
Topping up of public swimming pools or spas, including motels	Only between hours of 7.00am -9.00am and between 6.00pm -8.00pm, every day. Pool covers must be used.
Turf farm irrigation and market gardens	Businesses must implement and comply with a Water Saving Action Plan (WSAP).
New turf irrigation on non-residential premises	Not permitted
Pet care, child care and hospitals, hospices, nursing homes, rehabilitation centres, aged accommodation	Businesses must implement and comply with a Water Saving Action Plan (WSAP).
Construction Industry e.g. mortar or concrete mix	Permitted
<p>All other businesses and facilities must implement and comply with a Water Saving Action Plan (WSAP). Businesses and facilities include:</p> <ul style="list-style-type: none"> • Public car and truck wash facilities • Construction – wash down, paint preparation and curing • Cleaning – exterior • Commercial or Government nurseries • Abattoirs, food or pet food production and canneries • Public water features • Public parks, gardens, aviaries, plant houses and zoos • School, technical colleges and universities • Motels, caravan parks and cabins • Hotels and registered clubs • Businesses with cooling towers
